Advertisement for Recruitment of Warehouse Managers

Rajasthan State Warehousing Corporation is a statutory Government Corporation operating its warehouses at different places in the state of Rajasthan and the Warehouse Manager is the incharge of warehouses in the State.

Applications are invited from eligible candidates for filling up 65 posts of Warehouse Manager in the Rajasthan State Warehousing Corporation.

- Note**
- 1- Out of above total posts, one post is reserved for handicapped (Blindness or Low Vision).
 - 2- In case of non-availability of female candidates upto the required number, the vacancy shall be filled from male candidates of the same category and in the allocation of above posts female candidates will comprise of 5% widow and 25% others.
 - 3- In case of non-availability of other backward classes in prescribed number the vacancies shall be filled from amongst the candidates of General category.

The Corporation can at any time reduce or increase the number of above advertised vacancies.

2. Educational Qualification & Age for Warehouse Manager

Educational Qualification	Age
B.Sc. (Agriculture) with MBA/PG Diploma in Management	Minimum age of 21 years and maximum age of 35 years as on 01.01.2010 Relaxation of maximum 5 years in age limit for candidates belonging to Scheduled Caste/Schedule Tribes/Male Candidates of other backward classes and female candidates belonging to general category. Relaxation of maximum 10 years in age limit for female candidates belonging SC/ST/OBC classes Relaxation in the prescribed maximum age limit for handicapped candidates in the general category/other backward classes and SC/ST will be 10 years, 13 years and 15 years respectively. Relaxation of 5 years for the employees of Rajasthan State Warehousing Corporation.

3. Pay-Band (2) 9300-34800 and Grade Pay 4200 (13)/Remuneration:

Selected candidates shall be initially appointed on probation training period for two years and shall be paid monthly fixed remuneration of Rs. 13050.00. The Pay-Band (2) 9300-34800 and Pay Grade 4200 (13) and other allowances shall be allowed only from the date of successful completion of the probation training period.

4. Selection Process

The selection on the post of Warehouse Manager shall be made on the basis of interview. Average percentage of marks will be calculated by adding the aggregate percentage of the marks obtained by the candidate in B.Sc. (Agri.) and M.B.A./P.G. Diploma in Management and on the basis of this the categorywise merit shall be prepared. For example the aggregate percentage marks obtained by a candidate is 65% in B.Sc. (Agri.) and 55% in M.B.A./P.G. Diploma in Management. The average percentage of marks obtained shall be calculated by adding both and accordingly percentage marks shall be 60%. On the basis of above merit candidates for interview for selection on the post of Warehouse Manager shall be called upto maximum three times of the number of total 65 vacancies.

Note : The prescribed essential qualification are only minimum requirement and a candidate will not be entitled for personal interview merely on this basis. In case of excess applications, the corporation can reduce the number of candidates for interview on the basis of higher qualification rather than prescribed minimum qualification.

5. Caste Certificate

Certificate in the prescribed format issued by competent authority in Rajasthan will be considered. The caste certificate for other backward classes should not be more than six months old. Married female candidates shall have to produce caste certificate on the basis of her father's name, residence and income. The caste certificate issued in the name of her husband and income shall not be considered.

6. Non-eligibility for appointment

No person shall be eligible for appointment who has been previously dismissed from service of the State Government/Corporation/Board or who has been convicted by a court of law for any offence involving moral turpitude or who has more than one wife/husband living. A woman candidate will also be disqualified if she marries a person who already has a living wife. Further a person will also be disqualified if he/she has more than two children on or after 01.06.2002 provided a person with more than 2 children will not be disqualified unless the number of his/her children increase on or after 01.06.2002. Provided further that where a candidate has one child by previous delivery but from subsequent single delivery more than one child is born, the total number of children by such birth will be calculated as a single unit.

7. Last date for receipt of application

Application in the prescribed format duly filled alongwith required certificates and demand draft/pay order towards prescribed fee should reach the Office of the **Managing Director, Rajasthan State Warehousing Corporation, Bhawani Singh Road Jaipur – 302 015** on or before 30.06.2009 at 6.00 PM. Application received after this date will not be considered in any case. Applications received after the last date due to any reason will not be considered. The applicants will clearly indicate the name of the post applied on the envelop of application. Incomplete applications and application received after prescribed date will not be considered.

Format of the application form and procedure :

The following format of the application form may be downloaded from the website/typed on paper measuring 12" x 8" (A-4) size. The Corporation will not provide any application form separately.

Persons registered with the Planning Manpower Department, Government of Rajasthan will also have to apply under this procedure

8. Following attested documents will be enclosed alongwith the application :

- (a) Certificate of Secondary School Examination indicating date of birth.
- (b) Marksheet of the Secondary School
- (c) Certificate of graduation/post graduation (Agri.) with M.B.A./PG Diploma in Management and marksheet of each year/semester. Where grading is provided in place of marks then formula of grading will have to be clearly indicated. The certificates of educational qualification from recognized Board/School/Colleges/Institution/ University will only be valid for consideration and in case of false certificate the appointment shall be cancelled and action shall be taken as per rules.
- (d) Experience Certificate by competent authority, if any.
- (e) Certificate of Scheduled Caste/Scheduled Tribes/Other Backward Class issued by the competent authority.
- (f) Certificate of Handicapped issued by the competent authority, wherever applicable
- (g) Character Certificates by two gazetted officers which should not be issued prior to six months.
- (h) Marriage Registration Certificate, if married.
- (i) Death certificate of husband in case of widow and marriage divorcy certificate in case of divorced woman candidate.
- (j) Affidavit to the effect that the number of children has not increased to more than two after 01.06.2002 (appointment shall be cancelled if the affidavit is found to be false).
- (k) Attested copy of the bonafide resident certificate.
- (l) Certificate issued by component authority for candidate of TSP area, if

applicable.

Note: SC/ST/OBC (creamy layer, non-creamy layer) applicants of other states (out of Rajasthan) shall be treated as general candidate and such candidates can apply along with the prescribed application fee of Rs. 500.00 applicable to general candidates.
